**Buyer's Disclosure.** By signing below, the Buyer declares that the following statements are true and declares that he/she:

- Is not under the Federally-set legal age to own a firearm;
- Has never been convicted in any court of a crime punishable by imprisonment for a term exceeding one (1) year;
- Is not a fugitive from justice;
- Is not an unlawful user of or addicted to any controlled substance;
- Has never been adjudicated as a mental defective or has been committed to a mental institution;
- Is not an illegal or unlawful alien in the United States or a foreign visitor admitted to the United States under a nonimmigrant visa;
- Has not been dishonorably discharged from the U.S. Armed Forces;
- Is a citizen of the United States, has never been renounced their citizenship;
- Is not subject to a court order that restrains them from harassing, stalking, or threatening an intimate partner or child of such intimate partner;

- Has not been convicted of misdemeanor crime of domestic violence;
- Can lawfully receive, possess, ship, or transport a firearm;
- Is no under indictment or information for a crime punishable by imprisonment for a term exceeding one (1) year in federal or state prison.

**Seller's Disclosure.** By signing below, the Seller declares that the following statements are true and declares that he/she:

- Has verified that the Firearm details are correct and the serial number is readable and legible;
- Is the lawful owner of the Firearm and have the legal right to sell the Firearm;
- Has no knowledge of any defects in the Firearm;
- Believes the Firearm is capable to be used for its intended purpose;
- Believes the Firearm has never been used in a manner of questionable or certain illegality;
- Relinquishes all liability for the Firearm after the transfer of ownership has taken place.

**"AS IS" Clause.** The Parties agree that the sale and transfer of the Firearm is made on an "AS IS" basis and in an "AS IS" condition, without any express or implied warranties regarding the Firearm unless otherwise stated in this Agreement. The Firearm should be inspected by a competent gunsmith prior to using. Seller is not responsible for any damages incurred or caused by the use of this Firearm. This Agreement constitutes the only agreement between the Parties, and all other agreements, whether express or implied, shall have no force and effect except as stated in this Agreement.
